Beginning Monday, January 22, 2018, and continuing through the contest period, the rules and regulations for the Duck River Electric Membership Corporation Valentine's Getaway Giveaway will be available at <http://www.dremc.com>.

Contest Period

The contest period is from Monday, January 22, 2018, at 10:00 am CST through Friday, February 2, 2018, at 12:00 pm CST, with entries being accepted from Monday, January 22, 2018, at 10:00 am CST through 4:00 pm CST on Friday, February 2, 2018. The Grand Prize will be awarded on Friday, February 2, 2018.

How To Enter

Beginning Monday, January 22, 2018, and continuing through Friday, February 2, 2018, you can go to Duck River Electric's Facebook page (<https://www.facebook.com/DuckRiverEMC>) and click on the Valentine's Getaway Giveaway link where people may enter the contest.

A person can register once over the entry period for the contest by entering his or her e-mail address, first name, last name, home address and phone number. The entry must be submitted by the person whose name appears on the entry form; entries cannot be submitted for another person or in another person's name. During the entry process, an entrant may also choose to share the contest with their Facebook friends on their Facebook wall by clicking the "Share" button on the contest entry form. For each entry that results from the share, the person receives an additional entry, up to a total of 10 entries. This is the only way that a person can obtain additional entries in the contest. In the event of a dispute regarding the identity of the person submitting an online entry, the entry will be deemed to be submitted by the person in whose name the e-mail account is registered.

No entries will be accepted by mail or by delivery to any office of Duck River Electric Membership Corporation. Only entries posted on Duck River Electric's Facebook page (<https://www.facebook.com/DuckRiverEMC>) will be eligible. All entries must be posted by 4:00 pm (CST) on the date of the prize drawing – Friday, February 2, 2018. All entries must be completed in their entirety to be eligible to win.

How to Win

On Friday, February 2, 2018, just after 12:00 pm (CST), there will be a random selection process to determine one (1) Grand Prize winner. There will be no more than one winner of the Grand Prize during the contest period. If the randomly selected entry for the Grand Prize drawing meets all the entry and eligibility requirements, they will be designated as the Grand Prize winner.

The Grand Prize winner will be notified by phone and/or e-mail by a member of the DREMC staff according to the notification date. The Grand Prize winner's name may be included in a post on Facebook on Monday, February 5, 2018. If the winner's name and/or Facebook profile picture are deemed inappropriate, Duck River Electric Membership Corporation reserves the right to declare the winner ineligible and conduct another selection process to determine an

alternate winner. Winner must meet all terms of contest rules, including eligibility restrictions and conditions. Failure to meet any terms of eligibility or other conditions of this contest will result in forfeiture of the prize.
