If you qualify, this program is designed to give homebuilders rebates for properly installed, efficient electric or dual fuel heating and cooling units, energy-efficient water heaters** and dedicated electric vehicle charging stations.

Homes that qualify for our Platinum Package meet proven air-sealing standards, saving the homeowner money on energy costs and creating more comfort for your family.



PLATINUM PACKAGE

To qualify for the Platinum Package rebate, the new home must have both the blower door and duct blaster tests conducted and must pass the 2009 I.E.C. air tightness test standards.* The builder must also provide a copy of the Certificate of Occupancy, sign the New Homes Participation Agreement, and complete a questionnaire about the home at verification time. The first blower door and duct blaster tests are free of charge; additional testing will reduce the rebate by \$200 per test.

To qualify under the Standard Package rebate, DREMC requires a signed New Homes Participation Agreement, a copy of the Certificate of Occupancy, and a completed questionnaire about the home at verification time.
